THIS DIRECTIVE is issued in the exercise of the power conferred upon the Registrar by section 87A of the Patents Act 1983 [Act 291].

### **Citation, effective date and scope**

1. (1) This directive may be cited as the Directive of Patents Act 1983 and Patents Regulations 1986 (“this Directive”).

(2) This Directive shall be effective on 18 March 2022.

(3) This Directive sets out the Registrar’s direction for matters arising under the Patents Act 1983 (“the Act”) and the Patents Regulations 1986 (“the Regulations”).

(4) Any person who files any request or application, or make any appointment to the Patent Registration Office as specified in the Act and the Regulations shall comply with this Directive.

(5) The provisions of the Act, the Regulations and this Directive form the regulatory framework for the law of patents in Malaysia which shall be read together simultaneously.

### **Interpretation**

2. Unless otherwise defined, all words used in this Directive shall have the same meaning as defined in the Act and the Regulations.

### **Forms and fees**

3. (1) The forms to be used and filed with the Patent Registration Office for any matters stipulated in the Act and the Regulations are those set out in the First Schedule.

(2) The corresponding form of the prescribed fee specified under Schedule I of the Regulations are those set out in the Third Schedule.

### **Deposit of micro-organism**

3A. (1) For the purposes of regulation 7(1B) of the Regulations, the information under paragraph 7(1A) (a), (b), (c) or (d) of the Regulations shall be furnished to the Registrar by way of substituting Part VIII of Form 1 filed under subregulation 7(1) or Part VIII of Form 14 filed under subregulation 45(1), as the case maybe.

(2) The amendment of patent application or patent for the purposes of regulation 12D of the Regulations shall be made to the Registrar in Form 16 or Form 16A, as the case maybe, together with the payment of the prescribed fee.

## **Sequence listing**

4. (1) A sequence listing shall be submitted to the Registrar in the following standard:
- (a) a portable document format (.pdf); and
  - (b) standard as adopted under the Patent Cooperation Treaty.
- (2) A physical computer storage device accepted by the Registrar for the storage of the sequence listing mentioned in subregulation 18(12) of the Regulations are as follows:
- (a) compact disc read-only memory;
  - (b) digital versatile disc read-only memory;
  - (c) USB flash drive; and
  - (d) external hard drive.
- (3) The physical computer storage device shall be placed in an envelope with the name of the applicant and title of the invention clearly stated on the envelope.
- (4) The name of the applicant and title of the invention mentioned in paragraph (3) shall be identical with the name and title appearing in the request for the grant of a patent or in the application for grant of a certificate for a utility innovation.
- (5) If the physical computer storage device is unreadable, the applicant shall submit a new readable physical computer storage device containing a copy of the sequence listing.

## **Application for grant of written authority**

5. (1) Section 23A of the Act and regulation 7A of the Regulations shall apply to both applicant and inventor who is a resident as defined under the Act.
- (2) The description mentioned in subregulation 7A(2) of the Regulations shall—
- (a) contain the title of the invention as appearing in the application for the grant of a written authority;
  - (b) contain a minimum of one hundred and fifty words; and
  - (c) briefly describe the invention.
- (3) The Registrar may request additional information relating to the invention from an applicant if the description submitted by the applicant under regulation 7A of the Regulations is insufficient for the Registrar to make a decision in granting a written authority under section 23A of the Act.

(4) If the name of one or more inventors or applicants of an invention is not included in an application for the grant of a written authority that has been made to the Registrar and regardless the written authority for the invention has been granted or not by the Registrar, such inventors or applicants that is not included in the earlier application shall made an application for the grant of a written authority in the manner specified under subsection 23A(2) of the Act and shall comply with the requirements specified under subsection 23A(1) of the Act.

(5) Any person who files an international application for a patent or a certificate for a utility innovation with the Patent Registration Office as a receiving office shall made an application for a written authority in the manner specified under subsection 23A(2) of the Act unless if the requirements under subsection 23A(1) of the Act has been satisfied by such person.

(6) The application for the grant of a written authority shall not be entertained by the Registrar if the application is made after a request for a patent or an application for a certificate for a utility innovation has been filed outside Malaysia first without complying with the requirements under section 23A of the Act.

### **Publication of patent application**

6. The information relating to a patent application mentioned in subregulation 27F(1) of the Regulations which is in the possession of the Registrar prior to the completion of the preparation for publication shall be published in the Official Journal.

### **Conditions for refund**

7. A request for a refund of fees under subregulation 2(3) of the Regulations shall comply with the conditions specified in the Second Schedule.

### **Signature on document**

8. (1) Apart from a wet ink signature, any person may affix a facsimile signature on any document or thing filed at the Patent Registration Office in the manner specified in regulation 52 of the Regulations.

(2) The facsimile signature may be affixed to any document or thing uploaded to an electronic filing system specified in regulation 52A of the Regulations.

### **Address for service**

9. (1) For the purposes of furnishing the new address for service in the manner specified under subregulation 51(1) of the Regulations, the person concerned with any proceedings under the Act, the Regulations and this Directive may file one form for the furnishment of the new address for service in order for the new address for service to be applicable for all the applications or patents represented by that person.

(2) The one form mentioned in subparagraph (1) shall contain all the applications or patents represented by the person who files the form for the furnishment of the new address for service.

### **Excluded days**

**10.** (1) For the purposes of filing and service of documents and things under regulation 52 of the Regulations, the following days shall be regarded as an excluded day for all purposes under the Act, any regulations made under the Act and this Directive—

- (a) all days which are proclaimed as weekend holiday for Patent Registration Office and branch offices of the Patent Registration Office;
- (b) any day specified as or proclaimed to be a public holiday for Patent Registration Office and branch offices of the Patent Registration Office; and
- (c) any day proclaimed to be an excluded day as published in the Official Journal.

(2) For the purposes of electronic filing of documents and things under regulation 52A of the Regulations, the following days shall be regarded as an excluded day for all purposes under the Act, any regulations made under the Act and this Directive—

- (a) all days which are proclaimed as weekend holiday for Patent Registration Office;
- (b) any day specified as or proclaimed to be a public holiday for Patent Registration Office; and
- (c) any day proclaimed to be an excluded day as published in the Official Journal.

(3) Whenever the last day fixed by the Act, any regulations made under the Act and this Directive for doing any act or thing at the Patent Registration Office falls on a day which is an excluded day, it shall be lawful to do the act or thing on the first day following such excluded day which is not an excluded day.

### **Interrupted days**

**11.** (1) The Registrar may notify any day as an interrupted day where—

- (a) there is an event or circumstance causing an interruption in the normal operation of the Patent Registration Office; or
- (b) there is a general interruption or subsequent dislocation in the postal services of Malaysia.

(2) Any notification of the Registrar made under subparagraph (1) shall be displayed at the Patent Registration Office.

(3) The Registrar may, where the time for doing anything under the Act, any regulations made under the Act or this Directive expires on an interrupted day, extend that time to the next following day not being an interrupted day or an excluded day.

### **Delays in communication services**

**12.** (1) The Registrar may extend any time limit in the Act, any regulations made under the Act and this Directive where the Registrar is satisfied that the failure to do something under the Act, any regulations made under the Act and this Directive was wholly or mainly attributed to a delay in, or failure of, a communication service.

(2) Any extension under subparagraph (1) shall be—

(a) made after giving the parties such notice; and

(b) subject to such conditions, as the Registrar may direct.

(3) In this Directive, “communication service” means a service of documents under regulations 52 and 52A of the Regulations.

### **Computation of time**

**13.** For the purposes of the Act, any regulations made under the Act and this Directive, a period expressed in months and date from when an event ends—

(a) on the day, in the relevant subsequent month, which has the same number as the day of the event; or

(b) if the relevant subsequent months has no day with the same number, it shall be on the first day of the following month.
