THIS PRACTICE DIRECTION is issued in the exercise of the power conferred upon the Registrar of Trademarks by section 160 of the Trademarks Act 2019 [Act 815].

PART I

Preliminary

Citation, effective date and scope

- 1. (1) This practice direction may be cited as the Practice Direction No. 1/2019.
 - (2) The second variation made to the Practice Direction No. 1/2019 shall be effective from 1 February 2021 until further notice issued by the Registrar of Trademarks.
 - (3) This Practice Direction No. 1/2019 sets out the application under the Trademarks Act 2019 which is made available for filing in the Electronic Filing System ("the EFS").
 - (4) Beginning from the effective date of the second variation made to the Practice Direction No. 1/2019, the status of availability of the EFS is as stated in the First Schedule.
