MyIPO LEADS NATIONAL DIALOGUE ON INTELLECTUAL PROPERTY AND AI

PETALING JAYA, 18 AUGUST 2025 – The Intellectual Property Corporation of Malaysia (MyIPO) today hosted the National Dialogue on Intellectual Property and Artificial Intelligence (AI) at Menara MyIPO, PJ Sentral. The event was officiated by MyIPO Director General, Ms. Yusnieza Syarmila Yusoff.

The programme brought together policymakers, legal experts, researchers, academics, industry players and other stakeholders to explore how the rise of AI technology is reshaping the landscape of intellectual property (IP) protection in Malaysia and around the world.

With the theme "Owning the Future: IP in the Age of AI", the dialogue highlighted the importance of developing IP policies and legislation that can meet new challenges while taking advantage of the opportunities created by AI. Discussions focused on key issues such as the recognition of machine-generated works, the role of AI in patenting and design creation, and the protection of human-authored works in a rapidly evolving technological environment.

Around the globe, AI and IP have become pressing topics. The World Intellectual Property Organization (WIPO), through its WIPO Conversation series, has brought together stakeholders from many countries to deliberate on the potential of AI and the challenges it introduces. Some countries are considering legal recognition for AI-generated works, while others maintain that IP protection should remain grounded in human contribution.

This dialogue also serves as an important platform to bridge the gap between existing laws and emerging technologies, supporting efforts to develop IP policies that can withstand rapid changes in the future.

For the public, the outcomes of this dialogue will influence how people create, trade and consume digital content. Whether as designers, writers, entrepreneurs or users, the policy directions shaped here will determine how rights and protections for creative works and innovations are secured in the years ahead.

MyIPO believes that the insights and findings gathered from this National Dialogue will provide a strong foundation for crafting IP policies that are future-ready, progressive and aligned with global technological developments, helping to ensure that Malaysia remains competitive internationally.
