## 16.1 CIRCUMSTANCES IN WHICH A REGISTERED TRADEMARK AGENT IS REQUIRED

Under the Trademarks Act 2019 (TMA 2019), a **registered trademark agent** may be required or preferred to represent any person in circumstances as below:

- the preliminary procedure, or
- application for registration of trademark, or
- any procedure relating to a registered trademark
- any procedure under Madrid System

Any person who acts as a trademark agent without first registering as a valid agent may contravene Section 108 of TMA 2019 and shall, on conviction, be liable to a fine not exceeding fifty thousand ringgit (RM50,000.00) or two years imprisonment or both. (**Refer Section 95 to Section 98 of TMA 2019**)

## 16.2 PREREQUISITES FOR A REGISTERED TRADEMARK AGENT

A registered trademark agent can be an individual and/ or a company (Paragraph 39 GTM 2019). As an individual, a person must comply with the conditions as below;

- a citizen, domiciled in or permanent resident of Malaysia;
- practicing as an agent in a business registered in Malaysia;
- is not an undischarged bankrupt;
- has not been convicted of an offence involving fraud, dishonesty or any other offences under the Act;
- has attended all compulsory trademark agent courses as required under the Act; and
- passed the trademark agent compulsory examination conducted by the Registrar.

There are also some other additional requirements that must be met by any person who wishes to become an agent, namely;

- is on the Register of Patents\*
- is an advocate & solicitor in the High Court of Malaysia or High Court of Sabah and Sarawak who is practicing solely in Malaysia;
- hold a recognized degree in any field of studies & has had at least two (2) years' experience in IP; or
- has had three (3) years of experience in IP by virtue of being an ex-officer in the Corporation.

(Section 97 of TMA 2019 read together with Regulation 110 and 111 of TMR 2019)

As for a partnership or body corporate, it may be registered as a trademark agent should it comprises one or more registered individual trademark agent in such partnership or body corporate. (Paragraph 41 of the Guidelines of Trademarks 2019 (GTM 2019))

**\*Note:**

Registered and active Patent Agents are exempted from sitting for the examination. However, they are required to attend the two (2)-day preparation course.

## **16.3 PROCEDURE TO BE A NEW REGISTERED TRADEMARK AGENT**

### **16.3.1 Course of action**

- Must attend the compulsory two (2) days preparation course for the examination with prescribed fee.
- Submit application to sit for the examination by filing TMR1 with prescribed fee.
- Sit for the examination.
- Upon passing the exam, submit application for registration as a Trademark Agent by filing TMR2 with prescribed fee. TMR2 shall be accompanied by other documents such as;
  - Practice certificate (for agent whom is a legal practitioner)
  - Income Tax Certificate
  - Degree Certificate
  - Statutory Declaration (SD)

(Section 97 of TMA2019 read together with regulation 110 and 111 of TMR 2019)

- Upon satisfied the Registrar with all the documentation, the person will be accepted and registered as a trademark agent for a term expiring on 31 December of that year.
- Once registered, the agent's details and particulars will be recorded in the Register of Trademark Agents.

- Registration is to be renewed every year for its to be valid and enforceable.



## 16.4 RENEWAL OF REGISTRATION FOR AGENTS

### 16.4.1 Renewal Procedure

- To remain in the Register of Trademark Agents and enable an agent to act as such, a registered agent shall renew his / her registration annually as the term of registration expires on 31 December every year.  
Paragraph 42 of the Guidelines of Trademarks 2019 (GTM 2019)
- The application is made by filing Form TMR3 with prescribed fee.
- The earliest application for renewal as an agent is three (3) months before 31 December of the said year and will be lasted until 31 January the following year. Any application made after 31 January, may resulted in cancellation of registration and the name of the agent will be removed from the Register of Trademark Agents.
- Nevertheless, in a situation where the agent missed the dateline and fail to complete the application to renew within the specified time, he or she may have to file for extension of time (EOT) for a maximum period of six (6) months calculated from 31 January to allow the renewal application to be re-submitted. The related forms are TMR3 + TMK1 and TMK3.

## 16.4.2 Renewal Process

In addition to the requirements above, the agent must also prove that he continues to be, wherever applicable: -

- In the Register of Patents;
- An advocate & solicitor in the High Court of Malaysia or in the High Court of Sabah and Sarawak who is practicing solely in Malaysia;
- Hold a recognized degree in any field of studies & has had at least two (2) years' experience in IP; or
- Has had three (3) years of experience in IP by virtue of being an ex-officer in the Corporation;
- Has practiced as an agent for at least two years;  
*Refer paragraph 42 of GTM 2019*
- Is either a citizen, domicile in or permanent resident of Malaysia;
- Will be practicing as an agent in a business registered in Malaysia;
- Has not been convicted of an offence involving fraud, dishonesty or any other offences under this Act; and
- Has attended all the required courses
- Is not an undischarged bankrupt;

### **16.4.3 Consequences For Failing To Renew**


- If the agent does not renew his / her registration as an agent, the Registrar may cancel the registration and remove the agent's name from the Register of Trademark Agents.
- Once the name of agent is removed from the Register of Trademark Agents, all the applications or registrations of trademarks handled by the agent will be publish in the IPOJ. If this happens, it will affect the applications that are being represented by the said agent.
- Thus, the affected applicants or registered proprietors of the trademarks shall have to appoint and authorize a new agent to act on their behalf.
- However, to remedy the situation, the registration may be restored into the Register of Trademark Agents upon application to renew together with the payment of EOT for the delay period up to six (6) months is made.

## **16.5 PROCEDURE IF THE AGENT INTENDS TO CEASE TO ACT ON BEHALF OF THE PERSON**

There may be instances where an agent intends to cease to act on behalf of the person. This must be done accordingly:

- The agent shall file the notice of the intention to cease to act on the said person's behalf with the Registrar (Form TMR8 with prescribed fee for each application)
- The agent shall notify the person
- Upon the notice of the intention to cease to act has been paid and processed, the agent shall cease to be the agent for the said person



## **16.6 DEFERMENT OF RENEWAL OF REGISTRATION OF AGENT**

## **16.10 EXAMINATION FOR NEW TRADEMARK AGENT**

### Paragraph 40 GTM 2019

- A person who is interested and decided to become a trademark agent must sit and pass the examination held by MyIPO.
- The examination is conducted every year somewhere in October.
- Before that, candidates need to attend a two (2) days exam preparation course at MyIPO headquarters.
- Passing the exam is a mandatory requirement before a person is qualified to be accepted as a registered trademark agent.
- Any information on the preparation course and the exam shall be communicated via MyIPO website and other social media. Candidates may also direct refer to the officer in charge and / or the Intellectual Property Academy (IPA).
- The examination will cover related topics on IP, namely
  - Malaysian trademark law and designs law and practice;
  - Foreign industrial property law and practice
- Any candidates who fails and dissatisfied with the examination results may appeal for a review of results to the Corporation within 14 days after the results are released.

### **16.10.1 Appeal for re-scrutiny of result of examination of trademarks agent**

If the candidate/s does not satisfy with his result he or she **must submit Form TMR10**, accompanied by the **prescribed fee**, within **14 days** from the date the examination results are issued. [Refer to S. 162(1)(g)]. Upon receipt of Form TMR10, the Registrar (Second Examiner) will conduct a re-evaluation/re-examine of the answer script. After completing the second review, second examiner will inform the secretariat.

### **16.10.2 Procedure for appeal for a review of the result of examination**

An application to appeal for a review must be made in Form TMR10 accompanied with a prescribed fee **within 14 days** from the date of the result is released. (Section 162(1)(g) of TMA 2019)

Upon received of such application, the Examination Secretariat will submit the candidate's answer sheet to the second examiner for review. All decisions are final and there is no appeal thereafter.

The new result will be endorsed by the Examination Committee and Registrar will notify the result to the candidate.
